<b>Ineligible Entrants</b>	<p>Any person under the age of 18</p> <p>Employees (and their immediate families) of the Promoter, participating outlets and the agencies associated with this promotion are ineligible to enter this competition. Immediate family means any of the following: spouse, ex-spouse child or step-child (whether natural or by adoption), parent, step-parent.</p>
<b>Competition Period</b>	<p>The competition commences on Saturday 27<sup>th</sup> March at 3pm AEST.</p> <p>The competition concludes on Sunday, 29<sup>th</sup> August AEST (subject to change pending COVID-19 impacts on AFL season matches).</p>
<b>Entry Method</b>	<p>To enter, during the Competition Period;</p> <p>Eligible Entrants must become a 2021 GC SUNS member and redeem their membership ticket to attend a GC SUNS home game.</p> <p>Following the conclusion of each GC SUNS home game at Metricon Stadium, two Eligible Entrants will be selected as the Minor Prize winners.</p> <p>The two winners will be allocated at the following Home Game to take part in the 'Kick for a Plungie' activation. The member with the most points accrued at the end of the season will be the winner.</p>
<b>Entry Details</b>	<p>The Minor Prize winners will be selected from the pool of Eligible Entrants and invited to the next GC SUNS home game to participate in the 'Kick for a Plungie' activation.</p> <p>The Minor Prize winner with the highest score at the end of the season will win the Major Prize.</p>
<b>Maximum Number of Entries</b>	One entry per person, per game
<b>Draw Place, Date &amp; Time</b>	Each Minor Prize Draw will be conducted on the Tuesday following the conclusion of each home game.

<b>Notification Method</b>	Minor Prize Winners will be notified via phone and/or email and must acknowledge the ability to receive the Major Prize.
